**Pre-registration required by September 17, 2018.** Submissions without a completed registration form will not be accepted and/or assigned a contestant number at the time of drop off. Applications accepted from classes in grades K-5 only. Show management has the right to reject entries of an obscene or offensive nature.

**Please note the following additional requirements:**

Event is held at Salem County Fairgrounds, 753 Harding Hwy (Rt. 40), Pilesgrove, NJ. MoWSC will supply one bale of straw for displaying the scarecrow along with the contestant number. Contestant is responsible for supplying all other items needed to create and display the pumpkin. Electric is not permitted. Space is assigned at check-in, pull up to space to unload from 9 am to 3 pm. Vendors must be set up by 3 pm. Event begins at 4 pm and ends at 9 pm. No early break down. Use vendor designated parking area. Loading and unloading will be the sole responsibility of the vendor at the vendor's own risk.
